- All you need to do is to fill in the form and hand it in to the Shul office by Wednesday, 8 April 2020.
- Although not strictly necessary, it is preferable that the form be handed over directly to me, as you are appointing me to sell your *Chametz* on your behalf. This process takes no more than about 10 seconds! I am happy to receive forms at any mutually convenient time.
- If you are going to be away for the duration of Pesach, the process is the same, but you must either let me know, or write this at the top of the form, so that I can adjust the form accordingly.



## **SALE OF CHAMETZ**

Since one is not permitted to possess Chametz during Pesach, it is a practice where one has provisions of Chametz that one wishes to retain, to sell them before Pesach.

Rabbi Dansky is available to sell your Chametz on your behalf prior to Pesach.

You can do this by filling in the form below and returning it to the Shul office, or emailing [admin@cranbrooksynagogue.org.uk](mailto:admin@cranbrooksynagogue.org.uk) by Wednesday, 8 April 2020.

I/We, the undersigned, fully empower and authorise Rabbi Steven Dansky, of Cranbrook United Synagogue, to act in my/our place and stead, and on my/our behalf to sell all Chametz possessed by me (knowingly or unknowingly) as defined by the Torah and Rabbinic Law (eg, Chametz doubt or suspicion of Chametz and all kinds of Chametz mixtures). Also Chametz that is unfit for human food and that tends to adhere to a surface of the inside of pans, pots or cooking utensils. And to lease all places wherein the Chametz owned by me may be stored or found, especially in the premises specified below and elsewhere, up to and including Wednesday 8<sup>th</sup> April at 10.30am.
